## NWCG CURRICULUM MANAGEMENT ISSUE PAPER #132 REMOVAL OF THE SPANISH S-130 AND SPANISH S-190 FROM THE NWCG CURRICULUM February 1, 2016

NOTE: THIS CURRICULUM ISSUE PAPER HAS BEEN SUPERSEDED BY CURRICULUM ISSUE PAPER # 140, AS OF DECEMBER 13, 2022

## **BACKGROUND**

NWCG issued direction through the NWCG Executive Board memo dated May 17, 2004, stating all small unit leaders (anyone above the FFT2 level) must be proficient in the English language and the language used by the members of their crew/units. Based on this direction, the Training Working Team authorized the development of Spanish versions of S-130, Firefighter Training, and S-190, Introduction to Fire Behavior. There are now four courses required for FFT2: S-130, S-190, L-180 and ICS-100. L-180 and ICS-100 do not exist in Spanish. The English S-130 and S-190 courses are currently under revision.

## **CURRENT STATUS**

With revisions to the English versions of S-130 and S-190, the existing Spanish versions will contain dated content. After much discussion and data analysis, in December 2015, the Operations and Training Committee recommended to the NWCG Executive Board that the Spanish S-130 and S-190 courses be removed from NWCG Publications. The recommendation was approved by the Executive Board on January 27, 2016 (see attached Memorandum No. 16-001).

## RECOMMENDATION

Remove the Spanish S-130, Firefighter Training, and Spanish S-190, Introduction to Wildland Fire Behavior courses and associated components from the NWCG curriculum. Effective date for removal will be October 1, 2016.

**Background:** The S-130 and S-190 training courses are currently undergoing revision. The revised S-190 will be released in early 2016; the revised S-130 will be released in late 2016/early 2017. Because of these revisions, the Operations and Training Committee (OTC) evaluated the need to produce and maintain Spanish versions of these courses, and determined that the interagency demand from the field for Spanish versions of these courses does not warrant continued production and maintenance by NWCG.
